### TITLE INSURANCE FOR THE PURCHASE OF THE JACKSON/MAPLE SHADE TOWN FOREST PROPERTY

Allison Hope made a motion to obtain Title Insurance for the Jackson/Maple Shade Town Forest property with coverage in the amount of \$250,000 for a fee of \$1,045 per previous Selectboard authorization, seconded by Casey Mathieu. Motion passed: 2-0.

# REQUEST TO WAIVE RECORDING FEES ASSOCIATED WITH THE CONVEYANCE OF THE FORMER JACKSON (GAUTHIER) PROPERTY TO THE TOWN AND THE POULIOTS

Request to waive recording fees associated with the conveyance of the former Jackson (Gauthier) property to the Town and the Pouliots, conveyance of conservation easements to Vermont Land Trust and the Vermont Housing Conservation Board, and the conveyance of recreation pathway easement and community wastewater disposal system easements from the Hallers to the Town.

The Selectboard feels the request is for a unique situation. The property being conveyed will be owned by the Town and be community land, and all the property involved will be conserved. Therefore, the Board agreed to waive the recording fees as requested.

Allison Hope made a motion to approve the Capital Improvement Borrowing Tax Certificate regarding the Capital Improvement Note, seconded by Casey Mathieu. Motion passed: 2-0.

Allison Hope made a motion to authorize Greg Barrows to sign any and all finance documents requiring his signature as Treasurer with regard to the purchase of the Jackson Forest, seconded by Casey Mathieu. Motion passed: 2-0.
