Phase 1 Environmental Site Assessment Report & Next Steps: 1705 VT Route 128 Property

The Commission discussed the results of the Phase 1 Environmental Site Assessment. M. Manka stated that the underground tank will need to be removed and soils tested. The DEC, CCRPC, G. Pigeon, G. Gebauer, M. Letorney and M. Manka will be meeting on November 6th to discuss Phase 2 funding and procedures.
