The Board of Civil Authority met on Wednesday, August 20, 2014 at 7:00 p.m. at the Town Office.

Allison Weinhagen nominated Bob Bancroft as Chair, seconded by Paul Birnholz. Motion passed: 8-0.

ART WOOLF & CELESTE GASPARI – ABATEMENT REQUEST

Art Woolf and Katharine (also known as Celeste) Gaspari met with the Board with regard to their abatement request. Art stated that approximately six months ago an error was discovered in the Town's assessment of his property located at 557 Cambridge Road. The error caused an over assessment of the property and spans a five year period. He and Celeste are requesting an abatement of the taxes paid based on the error.

Lister Caroline Brown confirmed that there was an error. The Listers discovered the error when making a name change in the program for the 2014 Grand List. When a Change of Appraisal report was generated, the Woolf/Gaspari property appeard on the list. Because the only change that was made to the Woolf/Gaspari was to the ownership, the Listers researched why the Woolf property appeared on the list. It was determined that when changes were made in 2010 a "cost was not run" on all the changes therefore the assessment generated did not reflect the actual assessed value of the property at that time. The assessment should have been \$425,900 however the assessment that Art and Celeste have been paying taxes on was \$429,100. The Listers have corrected the error for the 2014 Grand List. Caroline advised because the "cost was not run" there was no way the Listers or the property owner would have known there was an error.

PATRICK LIBERTY - ABATEMENT REQUEST

Patrick Liberty was present to request an abatement for the property located at 694 Woods Hollow Road. The property belonged to his grandparents. His grandfather died several years ago and his grandmother recently passed away. The property is being taxed at the nonresidential tax rate and there is no state credit. Patrick is requesting an abatement to reflect an assumed state credit if his grandmother had been able to file a Homestead Declaration. Patrick advised that he lives on a fixed income and that a credit based on his income would probably be more than what he's requesting.

Unfortunately, because Patrick is not the owner of the property, the Board is unable to grant his request. The Board encouraged Patrick to contact the Town once probate has settled the estate and Patrick is the owner.
