- Westford-Milton Road re-paved in FY15-16. Old Stage Road in need of repaving, but will wait until we are eligible for another State paving grant.
- Seymour Road Bridge installed in FY15-16. Road washed out in a May 2013 storm. Installation delayed due to FEMA funding issues. Anticipating FEMA reimbursement later this year.

- Legal fees on the decline for the last two years thanks to fewer court cases.
- Spiller lot expense higher in FY16 due to funds for house demolition, including asbestos abatement.
  Demolition may happen in spring 2016 – still debating pros/cons. FY17 amount for loan principal only (interest accounted for separately).

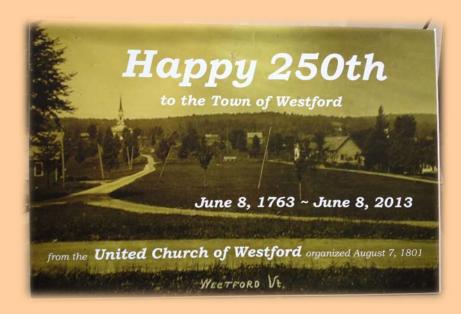
