TOWN OF WESTFORD ZONING BYLAW STATEMENT AND CERTIFICATION

I. Applicable Zoning Bylaws, Regulations and Ordinances.

The following zoning bylaws, regulations and ordinances have been duly adopted by the Town of Westford and govern the use and development of real property within the area affected by those bylaws, regulations and ordinances:

- (1.) Town of Westford has Land Use and Development Regulations, duly adopted on <u>June 7, 2018</u>, as amended from time to time, providing generally that no land development may be commenced within the area affected by such regulations without a permit therefore issued by the administrative officer.
- (2.) Town of Westford has Land Use and Development Regulations, duly adopted on <u>June 7, 2018</u>, as amended from time to time, requiring generally local subdivision approval to divide any parcel or area of land, for the purpose of conveyance, transfer, improvement, or sale into two (2) or more lots, plots or parcels. Further, Town of Westford requires among other things, that all plats be approved and recorded in conformance with 24 V.S.A. Section 4414, 4416 and applicable local regulations.
- (3.) Town of Westford requires a Certificate of Occupancy to use or occupy or permit the use or occupancy of all new principal structures and dwellings, said requirement having been incorporated into the Land Use and Development Regulations on June 7, 2018.
- (4.) Town of Westford has a Health Ordinance, duly adopted on <u>January 14, 1987</u>, as amended from time to time, prohibiting any unauthorized person from uncovering, making any connections with or openings into or disturbing any septic system without first obtaining a written permit.
