JOSEPH & DIANE FINNIGAN – ABATEMENT REQUEST

Joseph and Diane Finnigan were present to discuss their request to abate property taxes on their home that suffered damages caused by a fire on January 15, 2020. The Finnigans have been displaced from their home for four to six months while the home is repaired. Their insurance company has estimated the loss of structural damages to be approximately \$100,000. The Finnigans are requesting that the property taxes on their house be abated for the period of time they are displaced, which they are estimating to be approximately five months. It was noted that the Finnigan's house is valued at \$373,500.
