- Zoom call with Dean Pierce (Northwest Regional Planning Commission) and Dan Albrecht (Chittenden County RPC)
  - Dean and Dan are exploring potential partners for stream and river conservation.
  - Statewide, there is an ongoing effort to reduce nutrient loading in the lake]
  - Both Dean and Dan represent clean water service providers, which helps coordinate available funding.
  - There are funds available for restoration projects, and they are looking for an additional organization to join the Lamoille Basin counsel and aid in their watershed efforts to reduce nutrient loading.
  - An organization could be a separate entity from the Westford Conservation Commission and could work with citizens of Jericho and Underhill to protect the Brown's river top to bottom.
  - 0 Discussion
    - An org is a good idea, to have CCs to prop up the initial organization, but ultimately, members step up and take on leadership roles. Perhaps 1 member of CCs are present to support.
    - KT Can we use funding to hire project lead? Unlikely, as funds prioritize restoration projects.
    - Potential structure could be 1) organization can have one lead, town leaders for projects in town, and members from each town working towards each project, or 2) DA is interim leader of organization (manages project for each town), and eventually, each town brings its own leadership, and volunteers are drawn from the towns.

• WCC is interested in participating but would look for a broader discussion with other towns along the Browns River to see what the overall interest is and how it could be organized.
