# Minutes of June 16th Meeting-Review and approval

G. Lamphere makes a motion to approve the June 16th minutes as presented,

## **Land Use & Development Regulations Update**

WRO (Water Resource Overlay) buffers:

- DRB is requesting the Planning Commission reconsider the 100-foot buffer.
- The Planning Commission has questions for the DRB about the list they provided.

## Campground standards:

- H. Cism reached out to Allison Lowry (Westford's district wastewater representative) about the camp fact sheet they provide and how it is difficult to understand. The Planning Commission has been given a new updated fact sheet for clarity.
  - **H. Cism** has not heard back from them after requesting clarity on the 12 nights a year and whether that constitutes a campground regardless of how many sites you have.
- The Planning Commission discusses bringing questions to the DRB regarding their thoughts on campsites and where in the regulations for regular home sites they find it hard to figure out if it should apply to a campsite.

## Invitation to attend 8/11/25 DRB meeting:

The Planning Commission has been invited to attend the DRB meeting on August 8<sup>th</sup>,
 M. Tyler plans to attend this meeting. The meeting is primarily to discuss
 campgrounds; M. Tyler would like to ask them about the other items on the list
 they've provided to the Planning Commission. M. Tyler thinks until after this
 meeting with the DRB they should put a hold on discussion for these specific
 matters.

- **H. Cism** will make sure the DRB has an updated camp fact sheet in their packets for the August 8th meeting. She will send the Planning Commission an agenda for the DRB meeting when it is finalized.
- **W. Dunkley** will reach out to a contact he has who designs septic systems to see if he has any insight on the matter of campsites and WW.

#### **Public Outreach**

## Recap of PC Chair meeting with CCRPC:

- M. Tyler discusses his meeting with Darren Schibler and Kate McCarthy from CCRPC. He's provided notes from Darren in the Planning Commission's packet. CCRPC would like to assist Westford in any way they can but doesn't have Westford on their radar screen for this year aside from the traffic studies and the one intersection.
  - **M. Tyler** would like to be on their radar for next year to help with public outreach, help with applying for grant money, and to help with municipal planning (one phase might be 1705).
- **D. Schibler** noted places the Planning Commission should investigate for help with funding, CCRPC would also like to help with training.
- The Planning Commission discusses what public outreach looks like to them and discusses outreach and engagement for the town. They discuss outlets they can use for outreach such as the Town website, FPF, and the Town newsletter.
- The Planning Commission discusses whether it would be beneficial to answer the
  questions: why do we have a Town Plan and why do we have a Planning
  Commission? Would it be beneficial to have this discussion before updating the
  Town Plan? They feel this should be brought to the Selectboard to work on together.

M. Tyler will follow up with CCRPC.

The Planning Commission will split up the research regarding different funding options and find out more about each one.

## 1705 Update

**M. Reilly** says the Selectboard approved the assessment at the last Selectboard meeting. **H. Cism** says there were people doing wetland delineation last week so they should be getting that soon as well.

There was a discussion about the need for a new Town Office, the office is running out of vault space for records which statutorily the Town is required to have.

## Pedestrian Connection from Westford School to Village Center

- Taylor Newton at CCRPC said there are studies that they have on this subject that the Planning Commission can review.
- M. Tyler says P. Haller was in favor of looking into this again.
- **H. Cism** provided a map in the packet with the property owners whose property the easement would have to go through.
- The Planning commission discusses whether having a pathway like this would give more weight to keeping the school building in the community, they discuss the potential of having a walkway through part of the road rather than an easement on

someone's property, Brookside road does have a larger right of way than most of the roads in Town. The Planning Commission feel it could add a lot of value to the Town.

M. Tyler will review the documents Taylor Newton mentioned that are at CCRPC.

H. Cism notes that there are also documents here that they can look at from when it was previously presented.
