## UPCOMING CONSTRUCTION

### BROWNS RIVER COVERED BRIDGE REPAIRS

Westford's beautiful, covered bridge, originally built in 1838, repaired in 1976, and fully restored in 2001, will be getting some needed maintenance to keep it enjoyable for years to come, thanks in part to a grant from Vermont Historic Preservation. Water damage due to faulty flashing has caused the wood to rot at the four corners where the bridge sits on its concrete abutments.

The Selectboard has chosen Miles Jenness from Vermont Heavy Timber (<https://www.vermonthheavytimber.com/>) to do the repairs which will begin this summer and wrap up in the fall. The bridge will be lifted from the abutments, new wood timbers will be installed, and superior flashing will be applied to keep rot from forming again in the future. During this work, there will be times when traffic may be limited to one lane on Cambridge Road. Any disruption will be minimized as much as possible. Thank you for being patient while we fix up this wonderful, historic landmark in the heart of Westford!



## WINTER ROADS

What you need to know about winter road conditions.

- **Plowing:** begins when the snow has accumulated 2-3 inches. Each plow route takes the road crew about 4 hours to complete.
- **Sand:** applied to all gravel roads. Some particles may be large enough to cause windshield damage. Use caution and avoid following other vehicles closely.
- **Mailboxes:** Westford does NOT repair or replace mailboxes damaged by the plow.
- **Plowing Across Town Roads:** plowing snow from driveways across town roads is prohibited.

### Reminders:

- Each winter storm is different, roads may be icy and sand may be loose. Drive slow and know what your vehicle is capable of.
- Watch for walkers and wildlife. It will be more difficult to see pedestrians and recreational users of roads this time of year due to snowbanks. Walkers, bikers and other users can do their part by wearing bright, reflective clothing.
- Some VAST trails cross Westford Roads. Know where the trails are and watch for crossing snowmobiles. You can find a list of VAST trails here: <https://vtvast.org/trails.html>
- Several hunting seasons occur during early winter. Watch for vehicles parked on the side of roads for hunting access. Pedestrians & pets should wear orange/yellow reflective clothing during hunting seasons to help ensure they are seen. ## COMMON USE POLICY

The Westford Common Committee wants to remind residents that any major use of the Common or gazebo requires an application. This policy has been implemented to avoid conflicts since the Common and gazebo are being utilized more. ## DOG WARDEN

The Town of Westford is looking for someone who is interested in serving as Dog Warden. What is a Dog Warden? A Dog Warden is a person who helps dog owners comply with the Westford Dog Ordinance.

Qualifications: A love for dogs, the ability to communicate effectively and a location to bring dogs until they can be reunited with their owner to name a few. You may think you need a kennel to be a Dog Warden. This is not the case. However, a stray dog does need to be kept in a healthy environment until it is reunited with the owner. A healthy environment includes shelter, food, water, and a suitable area for them to relieve themselves.

The Dog Warden position receives an annual stipend of \$500 and there are funds available for training, supplies and mileage. The Town also has supplies, including a dog house, that can be utilized. ### Eyeglasses and Hearing Aids for Recycling

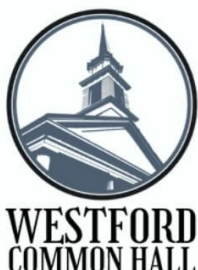

# TRASH, RECYCLING & FOOD SCRAPS IN WESTFORD

## Can I Recycle That?

Did you know that you are not supposed to put your recycling in plastic bags of any kind? The only exception to this is shredded office paper, which is accepted only if it's in a CLEAR BAG that's tightly closed.

Here are some other items that do NOT belong in your recycling bin:

- Dirty containers
- Plastic wrap
- Durable plastic (e.g., Tupperware, laundry bins, etc.)
- Styrofoam
- Motor oil or hazardous waste containers

## Food Scraps *(Effective July 1, 2020, per Act 148, food scraps are banned from landfills.)*

### What are food scraps?

Food scraps are parts of food that are typically discarded rather than eaten: peels, rinds, cores, eggshells, seeds, pits, bones, shells, coffee grounds and filters, loose-leaf tea, and fats/oils/grease. Food scraps is also food that was eaten but not finished: "plate scraps" or leftovers that went bad. Any type of food can become food scraps including bread, pasta, soup, vegetables, fruit, sauces, meat, fish, dairy, sweets, etc.

### What should I do with meat and bones?

If you compost in your yard, the law allows you to put meat and bones in the trash, so they don't attract animals to your composting bin. If you chose to bring food scraps to a drop-off center, you can include meat and bones with the rest of your food scraps.

## SEASONAL COMPOSTING TIPS: WINTER

- Leaves and grass clippings are valuable compost materials because they are carbon rich. Add them in small batches to avoid matting (too many leaves clump together and slow down the compost process)
- Cover your pile or use an enclosed composter to keep things moist but not sodden. This will also deter pests like bears, raccoons, and mice.
- Other items that can go in your compost this time of year include wood ash and the skeletons of annual flowers & plants. Break down large-bodied plants like tomatoes and broccoli before adding them to your pile.
- Store compost material like leaves & grass in a burlap sack near your pile for adding with food scraps.

# Legislative Updates

## Brenda Steady

Three weeks have passed since the start of the new legislative session, and I continue to serve on the Human Services Committee. Our committee recently completed recommendations to the Appropriations Committee on the Budget Adjustment Act. Many organizations came before us to request additional funds.

We have now divided into teams, with each team assigned a portion of the Human Services budget to research. Our task is to understand the requested increases and develop proposals to bring back to the full committee. The committee will then review each team's recommendations and vote on whether to advance them to Appropriations.

I hope the proposals moving forward will be fiscally responsible. While I understand many of the requests, some appear quite costly, and I question whether they reflect mismanagement of original budgets. A few line items involved fiscal errors, which can happen. Several organizations also requested entirely new funding; those groups were asked to return when the committee begins testimony for the FY27 budget.

H.545 – An act relating to issuing immunization recommendations

The committee heard testimony from Dr. Rick Hildebrant, MD, the new Commissioner of the Department of Health. The bill authorizes the Department to issue immunization recommendations for children and adults as part of its immunization program. It also allows the Department to secure the best possible vaccine pricing from vendors. Under the bill, recommended immunizations would have no co-payments, coinsurance, or deductibles. Membership of the Vermont Immunization Advisory Council would also be updated.

This bill passed on the House floor and now moves to the Senate. I voted yes.

Governor's State of the State Address

On Wednesday, January 7th, I listened to the Governor's State of the State address. The primary focus was Education Reform, which he described as essential for affordability, housing, workforce development, economic growth, and Vermont's future. He also addressed rising education spending, childcare, infrastructure, and public safety. [Governor Phil Scott Delivers 2026 State of the State Address | Office of Governor Phil Scott](#)

Additional Bills Voted On

- H.649 – Proposes prohibiting certain loans and investments by risk retention groups, restructuring reporting requirements, and requiring certification statements from protected cells within sponsored captive insurance companies. I voted yes.
- S.60 – Establishes the Farm Security Special Fund to assist farms experiencing qualifying weather-related losses. I voted yes.
- H.84 – Allows telehealth appointments to be recorded with patient and provider consent. I voted yes.
- H.534 – Relates to community action agencies. I voted yes.

Housing Legislation

The committee is also working on a new housing bill following last session's veto of H.91. The new proposal, H.594, would establish the Temporary Emergency Housing and Accountability Program and the Return Home Program for fiscal years 2027 and 2028. The bill carries significant costs: \$60 million in 2027 and \$50 million in 2028.

I am extremely concerned about these costs, and with my continued focus on affordability, I am doing my best to keep an open mind as we hear testimony. A constituent contacted me with concerns about nonresidents receiving free housing. I share this concern, particularly when Vermonters are turned away due to limited room availability. I raised this issue in committee, and the Chair invited legislative counsel to explain why such restrictions cannot be included in the bill.

I also asked whether individuals who receive assistance to return to their home state may later return to Vermont and re-enter the hotel/motel program. The short answer is yes.

Committee Livestreams

All committee meetings are livestreamed, and I encourage constituents to listen in. Agendas and livestream links can be found on the State of Vermont committee webpages. I welcome feedback and suggestions to help me make informed decisions when votes are taken.

Community Recognition

Representative Taylor, Senator Mattos, and I had the pleasure of welcoming the Milton Varsity Boys Soccer Team to the State House last week. They sat in the House balcony as Resolution H.C.R. 159 was read, recognizing their 2025 Division II Championship title. Go Yellowjackets!

This week, I also signed onto my first Essex Westford School District resolutions, recognizing the 2025 Hornets Girls' Volleyball Team for winning their fifth consecutive Division I Championship, and the 2025 Essex High School Hornets Boys' Volleyball Team for winning the state championship. Go Hornets!

#### Kid Governor Visit

Our committee heard testimony from the newly elected Kid Governor, who ran on a platform focused on homelessness. She shared thoughtful ideas for projects she hopes to lead, including a Fun Run, a potluck meal, and a food and clothing drive.

### Chris Mattos

The 2026 legislative session has begun! Like most times in the second year of the biennium, the legislature hits the ground running continuing to work on bills from the previous session and anything new for 2026.

Most notably, continuing the foundation of Act 73 of 2025, the transformation of education bill. This was the main focus of the Governor's State of the State in early January. Over the summer a task force was assembled to provide the legislature with up to three district maps. The task force took a different approach by providing options the legislature could take and came up with "Cooperative Education Service Agencies". In the afternoon committee I serve on, Senate Finance, we received a briefing on what these agencies are and how they would work. The focus of these agencies is to provide regional shared services to districts for services that are inefficient or difficult to deliver locally. I will continue to work on ensuring our education system can be more effective for the taxpayers, our schools and most importantly the children.

In the morning, I serve on the Senate Judiciary committee where we have been deeply involved in the confirmation process for two Vermont Supreme Court Justices, Christina Nolan and Michael Drescher. A little about the process, when there is a vacancy on the Supreme Court, applicants are reviewed by the Judicial Nominating Board. The nominating board interviews candidates and provides a list of qualified candidates to the Governor for his appointment. In this case, two nominees were appointed to fill the two vacancies and now the Senate Judiciary committee also interviews the nominees and receives testimony from the public followed by a vote to send each nominee to the full Senate for confirmation. The nominees have done an honorable job during the process by answering the committee's questions and responding to public testimony. The full Senate is expected to vote on the confirmations in early February. In Judiciary, we have also been working on two bills, S.208 and 209. 208 is an act relating to standards for law enforcement identification which would require all law enforcement officers to display their name and badge number. In addition, officers would be prohibited from wearing masks or personal disguise unless they meet certain exemptions. S. 209 is an act relating to prohibiting civil arrest in sensitive locations which currently applies only to court houses. The bill aims to expand sensitive locations to state, county or municipal buildings, schools, community-based shelters, and healthcare facilities. There are some constitutional concerns and exactly how these bills would be enforced that I'm still gathering information on. Much more to come on both these bills.

I hope everyone can get out and enjoy some winter activities as the legislative session begins to warm up!
